2. Scope

This policy applies to all employees, contractors, freelancers, partners, and third-party collaborators who create, contribute to, or have access to VioPixel's intellectual property. It covers, but is not limited to:

- Brand assets, logos, and marketing materials

3. Ownership of Intellectual Property

agreement (NDA) states otherwise.

• **Open-Source & Third-Party Tools:** If external code, fonts, assets, or plugins are used in any project, proper licensing and compliance with copyright laws must be ensured. Employees must not incorporate unauthorized third-party content into VioPixel or client projects.

4. Employee & Contractor Responsibilities

- Employees and contractors must not distribute, share, or use VioPixel's intellectual property outside of their work obligations.
- All VioPixel-created work must remain within the company's secured digital infrastructure unless approved for external use.
